Ferry County Forest Management Plan Guidelines

1. Parcel identification number and brief legal description.
2. Owner's goals and objectives for the parcel.
 - a. Will the primary use be for the growth and harvest of timber?
 - b. Will it be used for livestock grazing or other uses?
3. Site map and aerial photo with a description of existing timber stands, species, diversity, health & volume.
4. Site map/aerial photo with intended timber stand improvements shown..
5. Number of stocked acres qualifying for the classification *WAC 222-34-020(2) Acceptable stocking. Stocking levels are acceptable if a minimum of 150 well-distributed, vigorous, undamaged seedlings per acre of commercial tree species or such lesser number as the department determines will reasonably utilize the timber growing capacity of the site have survived on the site at least 1 growing season. "Well-distributed" means that not more than 20 percent of the harvested area contains less than a minimum of 120 trees per acre as determined by the department.*
6. Timeline for completion of various timber stand improvements by area:
 - a. Thinning and cutting, both commercial and noncommercial.
 - b. Brush abatement, fire fuels clean up.
 - c. Method of insect, disease and weed control.
7. Reforestation methods and time schedules.
8. All owners must sign the Forest Management Plan.
