RESOLUTION NO. 2006-22

AMENDING RESOLUTION 99-30

APPROVING AND AUTHORIZING THE IMPOSITION OF LIMITED FEES ON COURT FILINGS AND MARRIAGE LICENSES TO FUND A COURTHOUSE FACILITATOR PROGRAM ENACTED TO ASSIST FERRY COUNTY RESIDENTS WITH LEGAL PAPERWORK FOR FAMILY LAW CASES;

WHEREAS, the Washington State legislature has authorized counties to establish Courthouse facilitator programs to provide basic services to parties of court proceeding who do not have attorneys; and

WHEREAS, the Washington State legislature has authorized counties to impose a surcharge of up to twenty dollars on Superior Court cases filed under Title 26 RCW for the purpose of funding such a program, pursuant to RCW 26.12.240; and

WHEREAS, the Washington State legislature has also authorized counties to collect up to fifteen dollars on marriage licenses for the purpose of funding family services; and

WHEREAS, the Board of Commissioners seeks wished to increase the current fees from ten dollars to twenty dollars to assist the residents of Ferry County who are involved in litigation and do not have an attorney.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Ferry County that a part-time contract court facilitator shall be provided for and shall be managed by the Ferry County Clerks Office to assist litigants in the preparation and filing of paperwork and documents in family law cases; and

BE IT FURTHER RESOLVED that the cost and expense of the facilitator position established above shall be funded and paid out of a twenty dollar surcharge, which shall be assessed by the Ferry County Clerk in addition to filing fees otherwise allowed by law on cases filed under Title 26 RCW. The fees imposed by this resolution shall be collected by the Clerk, effective July 24, 2005, and deposited in the Court Facilitator Program Fund, to be used to pay the cost and expenses of the Court Facilitator and Facilitator Program.

BE IT FURTHER RESOLVED, that they hereby establish a fifteen dollar increase to the current fee for marriage licenses, raising the fee to a total of forty-five dollars and that the increase for marriage licenses shall be applied toward funding the Courthouse Facilitator Program. The fund collected as a result of the increase in marriage license fee shall be deposited to the court Facilitator Program Fund to be used to pay the cost expenses for the Court Facilitator and the Facilitator Program.




SCHEDULE OF FEES
AMENDING RESOLUTION 2003-49**

WHEREAS, Ferry County was in need of establishing a county-wide Schedule of Fees to maintain consistency in each department and to provide the public with a list of all fees; and

WHEREAS, on August 4, 2003 the board of Ferry County Commissioners adopted Ferry County Resolution No. 2003-28 reflecting various fees charged by county departments; and

WHEREAS, the fees set by the Ferry County Auditors Office/Elections for copies of maps are inadequate to cover actual costs incurred for such copies; and

WHEREAS, the Assessor's Office Fee Schedule was inadvertently omitted in Resolution 2003-28; and

WHEREAS, the Large Format Copier Fund Fees was inadequate to cover necessary charges of scanning documents to the server.

NOW THEREFORE BE IT RESOLVED, that the following Schedule of Fees is to be used for basic charges, however any fees authorized by RCW's can/will be subject to change without notice.


