
The primary duties and functions of a CDMHP are to:

1. Perform the duties of County Designated Mental Health Professional in conducting and processing involuntary investigations and other crisis emergency services on call to determine whether someone is an endangerment to self or others due to a mental illness, per the regulations in WAC 275-54 and WAC 275-55.
2. Perform counseling therapy, suicide assessments, referral services, follow-up and evaluations through Ferry County Community Services Mental Health Programs.
3. Provide public education in the area of prevention of Mental Illness, Alcoholism, and Drug Abuse.
4. Provide consultation and services to other agencies.
5. Provide information and feral services to clients.

Duties and priorities will be established under the supervision of the Ferry County Community Services Administrator and Clinical Director.







WHEREAS, the budget balance for the 2006 budget for the District Court Office under the budget item Salaries and Benefits is inadequate to cover necessary expenditures; and


WHEREAS, sufficient funds remain in the budget item listed below Jury Fees and Legal Aid.

NOW THEREFORE BE IT RESOLVED that funds in the amount of \$1500.00 be transferred as follows:






