

**RESOLUTION 2007-11**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REPUBLIC, WASHINGTON, to increase the regular property tax levy by 15.11% (or as allowed by law) from what was levied the previous year.

**WHEREAS**, The City Council of the City of Republic has properly given notice of a public hearings held on November 5, 2007 and November 19, 2007, to consider the City of Republic's current expense fund budget for the 2008 calendar year, pursuant to RCW 84.55.120; and

**WHEREAS**, the City Council, after hearing, and after duly considering all relevant evidence and testimony presented, has determined that the City of Republic requires a regular levy in the amount of \$121,365.00, which includes an increase in property tax revenue from the previous year, in addition to amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amounts authorized by law as a result of any annexations that have occurred and refunds made, in order to discharge the expected expenses and obligations of the district and in its best interest; now, therefore,


**WHEREAS**, The City of Republic had an assessed valuation levied for collection in 2007 of \$105,435.00; and

**WHEREAS**, the City of Republic has determined that it is in the best interest of and necessary to meet the expenses and obligations of the City of Republic for the property tax revenue to be increased in the next calendar year;

**NOW THEREFORE, BE IT RESOLVED**, by the City Council of the City of Republic that an increase in the property tax levy is hereby authorized for the 2008 levy in the amount of \$15,930.00, which is a percentage increase of 15.11 percent (or as allowed by law) over the amount levied for collection in 2007.

This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.
