ELECTION TO RECEIVE PAYMENT UNDER PL 110-343

WHEREAS, Congress enacted in 1908 and subsequently amended a law that requires that 25 percent of the revenues derived from National Forest lands be paid to states for use by the counties in which the lands are situated for the benefit of public schools and roads; and


WHEREAS, Title III of PL 106-393 was reauthorized by PL 110-343 which provides the implementation of the Firewise program, development of a Community Wildfire Prevention Plan or Search and Rescue/Emergency Services on Federal Lands; and

WHEREAS, Ferry County elects to receive its full payment amount pursuant to Title 1, section 102(a) and section 103 (a,b,c) of PL 110-343; and

WHEREAS, Ferry County allocates 15% of the full payment amount for expenditures on projects under Title II and Title III. The County will return zero percent of its full payment amount to the General Treasury of the United States.

NOW THEREFORE BE IT RESOLVED that Ferry County elects to allocate 8% of the project funds for expenditures on Title II projects and 7% of the project funds for expenditures on Title III project for the federal fiscal year 2010.

Last year your resolution was No. 2008-31. You need to make a few corrections; P.L.106-393 was reauthorized by P.L.110-343. Title III is limited to implementation of the Firewise program, development of a Community Wildfire Prevention Plan, or Search and Rescue/ emergency services on Federal lands. The authorizing section of P.L.110-343 is Sec. 102 (a) and Sec. 103 (a, b, c). Title III is limited to a maximum of 7%.
