

1996 Dodge 2500 4X4 Pickup, serial #1B7KF26Z3TJ194496 FCPW Equip #115







DESIGNATION OF APPLICANT AGENT FOR  
PROPERTY TAX RETURN CERTIFICATIONS

WHEREAS, pursuant to WAC 458-18-210 all claims for refund of property tax returns must be certified by the county Assessor and Treasurer and not to be refunded until ordered by the county legislative authority; and

WHEREAS, the Board of Ferry County Commissioners' hold weekly meeting's to conduct county business and are away from the office serving on other Boards and Committees the remainder of the week. While processing claims there is interest calculated and paid on the property tax returns and the interest accumulates from day to day; and



**PROJECT DRAWINGS AND SPECIFICATIONS APPROVAL**


