

**FERRY COUNTY RESOLUTION 2012-35
SCHEDULE OF FEES
AMENDING RESOLUTION 2009-41**

WHEREAS, Ferry County was in need of establishing a county-wide Schedule of Fees to maintain consistency in each department and to provide the public with a list of all fees; and

WHEREAS, on 3rd day of August, 2009 the board of Ferry County Commissioners adopted Ferry County Resolution No. 2009-41 reflecting various changes in fees charged by county departments; and

WHEREAS, the fees set by the various Ferry County departments need to be updated to cover rising costs.




