# **Fairgrounds Update**

Fairgrounds Manager Wayne Egner came before the Board to give an update on a grant that Fairgrounds Manager Sue Egner applied for. Mr. Egner reported that the County has received a new agriculture grant for the horse barns in the amount of approximately \$70,000. Discussion was held on the six hundred feet of eve lighting. Mr. Egner reported on the plan for a new pole building and asked if he had to put it out for bid. Commissioner Miller asked Clerk Amanda Rowton to work with Public Works Controller Sharon Sattler on the bid process. Discussion was held on the new pole building. Commissioner Blankenship asked Mr. Egner if he had permission from FEMA to build on the designated site. Mr. Egner assured the Board that he did have permission to build on the site.
