ESTABLISHING SIGN INSTALLATION FEES
FOR PUBLIC WORKS DEPARTMENT

WHEREAS, Ferry County Rural Addressing Ordinance No. 95-05 was adopted on August 7, 1995; and

WHEREAS, Section 2: Signage of Ordinance No. 95-05 under subsection 2.a provides:

Private Road Intersecting with County Roads. The County Public Works Department will install private road signs on County Roads. Once property owners or residents have purchased their signs, they must contact the Public Works Department to schedule the installation of the signs; and

WHEREAS, established fees are no longer covering the cost of materials and installation.


NOW THEREFORE BE IT RESOLVED that the following fee schedule is hereby adopted for installation of private road signs;

\$150.00	\$120.00

BE IT FURTHER RESOLVED that the above fees include labor, truck time, post, nuts/bolts, bracket, and administrative fees.




